# **SWIPCO Honored by ICOG for Harvest Hills Development**

DES MOINES – Southwest Iowa Planning Council (SWIPCO) has been awarded the 2024 Innovative Project Award from the Iowa Association of Councils of Governments (ICOG) for work with the City of Woodbine on the Harvest Hills Development. The award was accepted at the ICOG Staff Retreat in Des Moines.

SWIPCO worked with the City of Woodbine to apply for and obtain a Community Development Block Grant from disaster recovery funds following the 2019 Missouri River floods to create an affordable housing project.

SWIPCO worked with the city and NuStyle Development to administer funds and help coordinate the project to construct 40 new homes and the supporting infrastructure in the Harvest Hills subdivision located on the west edge of Woodbine.

SWIPCO's Ashley Hayes, Erin Hudson, Aaron Koontz, Mary Auten, and Barb Boggs had hands on the project. The team has filled many roles along the way after helping obtain the initial grant funding. SWIPCO

has helped 2019 flood displaced and low to moderate income residents match with the new housing opportunities, assure that federal standards and guidelines are followed, coordinated planning, and assured proper paperwork has been filed.

Disaster Recovery Coordinator Ashley Hayes said, "I'm proud of our team here at SWIPCO and how quickly we all adapt to the ebbs and flows of grant work at this scale. The rapport each one of us has developed with each of the developer's team members and with the City of Woodbine, as well as IEDA, has been very helpful throughout this project and others as well. We are excited for the city to continue to thrive with this additional housing and infrastructure and it's great to know there are individuals and developers that are willing to invest in our rural communities. It's exciting to know that our work as a team has been recognized in this way."

## Atlantic, Essex, and Harlan Receive CDBG Awards

SWIPCO has helped obtain Community Development Block Grant Water and Sewer Awards for the cities of Atlantic, Essex, and Harlan recently.

Harlan obtained an award to conduct CIPP lining of approximately 22,000 linear feet of sewer mains and some spot repairs of mains that are too dilapidated to line. The total project is estimated at \$1,320,000 and the CDBG award was for \$500,000.

The City of Atlantic is set to work on a new clearwell, which is the final storage stage for a municipal drinking water purification system. They are receiving a \$500,000 CDBG for the project. Atlantic also has recently been informed by IEDA that they have been awarded an lowa Energy Efficiency and Conservation Block Grant in the amount of \$154,033 for a street light project.

The City of Essex has also been awarded a \$500,000 CDBG for a water project. They will be constructing a new water tower to serve their municipal drinking water system.

SWIPCO is excited for these communities to be able to tackle these projects and looks forward to working with other communities in the region to apply for and obtain grant funds.

# **Pottawattamie County Drivers Pass Latest TSA Test**

SWITA has been working with TSA officials for many months now on testing drivers ability to follow safety protocols. In our latest round of testing drivers in Pottawattamie County passed a set of random tests with a 100% success rate.

We will continue to have some random safety testing into the future to encourage drivers to be vigilant with the safety of their vehicles.

We celebrated the achievement of the Pottawattamie County crew with some breakfast pizza and donuts on May 10th. Great work crew!

#### **New Buses Arrive at Critical Time for SWITA**

Transit agencies across the country have been battling a major shortage of available new buses to replace aging fleets. Southwest Iowa Transit Agency unfortunately knows this need all too well. Record ridership combined with a lack of replacement vehicles has put SWITA at the top of the list for oldest fleets in the state and near the top nationwide. This month has brought some good news to start alleviating this problem with the arrival of five new buses.

SWITA recently took delivery of five 2024 Ford Glaval 18-passenger cutaway buses from Hoglund Bus Company. These vehicles were originally ordered in 2021

but have only now just arrived. A multitude of factors have contributed to this bus shortage and delay nationwide, but the issue was exacerbated by the COVID-19 pandemic. The number of bus manufacturers in the country had already started to dwindle with consolidation but the pandemic caused the industry to shrink to two major manufacturers. Supply chain issues combined with reduced capacity further delayed production. Starting from the lack of available chassis to start with all the way up to high demand for competing products like campers. An added layer that has slowed things down is manufacturing requirements for the Build America, Buy America legislation. Stakeholders in the transit industry have been working with legislators and manufacturers to try to break through the logiam.

The pandemic also resulted in record investment in public transit infrastructure, so it's been a bit of a catch-22 to see results. Cost is another factor that has made procurement a big challenge. Back in 2021 these buses would have cost about \$86,000, but continued cost increases and inflation have ballooned that figure all the way up to over \$160,000 per bus today. Cost adjustments require contract changes, further slowing the process. That's why it is a big deal for SWITA to see some new vehicles show up on the lot. Ideally SWITA should take delivery of 10 new vehicles a year to keep up with wear and tear. Until that pace returns SWITA will continue to invest heavily in maintenance of existing buses and purchasing used buses where they make sense.

SWITA is excited to get these new vehicles rolling and will continue to put effort into improving the bus ecosystem.

# **Southwest Iowa Families Celebrates New Facility**

Southwest Iowa Families Inc. celebrated their new space at the Lakin Foundation Child and Family Center in Clarinda on May 8th. The organization hosted an open house and had a ribbon cutting for staff, partners, and the public. The organization provides mental health and other support services in the region.

Construction on the facility began in 2022 and was finished in December of 2023 for the 9,000 square foot space. Approximately \$2.9 million dollars was raised for the project. SWIPCO assisted in securing a \$600,000 Community Development Block Grant for Community Facilities and Services.
